Appellate Authority

If you are not satisfied with the response of the Nodal Officer, you may escalate your complaint / grievance to the Appellate Authority as a final mechanism for grievance resolution during working hours (9:30 AM to 6:00 PM) Monday to Friday. This should please be done by filling up a form prescribed by TRAI in Duplicate. • Procedure for making appeals before the Appellate Authority

o Appeal must be in the format prescribed in the regulation (in duplicate) - (for format [click here](#))

o Every appeal must be filed within 3 Months from the date of decision of the Nodal Officer. o

All appeals are generally disposed of within 3 Months from the date of filing of appeal.

o Appeals only against the decision of the Nodal Officer are maintainable before the Appellate Authority, no other appeal / direct complaint shall be entertained.
